This Supplement (the **Supplement**) to the prospectus dated 7 August 2025, as supplemented by the supplementary prospectus dated 24 October 2025 and 27 February 2026, which together comprise a base prospectus (the **Prospectus**) for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the **UK Prospectus Regulation**), constitutes a supplementary prospectus for the purposes of Article 23 of the UK Prospectus Regulation, and is prepared in connection with the €60 billion Global Covered Bond Programme (the **Programme**) established by Lloyds Bank plc (the **Issuer**).

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus and the documents incorporated by reference therein. Capitalised terms used in this Supplement but not defined herein shall have the meanings ascribed to them in the Prospectus.

This Supplement has been approved by the Financial Conduct Authority (the **FCA**), as competent authority under the UK Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Approval by the FCA should not be considered as an endorsement of the Issuer and/or Lloyds Bank Covered Bonds LLP (the **LLP**) or of the quality of the Covered Bonds that are the subject of this Supplement.

The Issuer and the LLP each accept responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Issuer and the LLP the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of this Supplement

The purpose of this Supplement is to:

- (a) incorporate by reference into the Prospectus, the Issuer's Q1 2026 Interim Management Statement (as defined in this Supplement) which was published by the RNS on 29 April 2026; and
- (b) update the no significant change statement of the Issuer and its subsidiary and associated undertakings (the **Lloyds Bank Group**).

Any documents themselves incorporated by reference in the Issuer’s Q1 2026 Interim Management Statement shall not form part of the Prospectus, unless specified otherwise here.

(b) NO SIGNIFICANT CHANGE OF THE LLOYDS BANK GROUP

The no significant change statement of the Lloyds Bank Group in the first sentence of the first paragraph under the section headed “*Significant or Material Change*” on page 276 of the Prospectus shall be deleted in its entirety and replaced as set out below:

“There has been no significant change in the financial position or financial performance of the Lloyds Bank Group since 31 March 2026, the date to which the Lloyds Bank Group’s last published unaudited financial information (as set out in the Issuer’s Q1 2026 Interim Management Statement) was prepared.”
