### Covid-19

In response to the ongoing Covid-19 situation in the UK, from 6 April 2020 credit card borrowers impacted financially by Covid-19 can request a payment holiday for up to three months. The payment holiday request deadline is 31 October 2020 and customers are now able to apply for a further 3 month payment holiday on expiry of initial payment holiday. Where borrowers have made a successful application, they are not considered to be in a payment shortfall and as such will not be reported as delinquent. Payment holidays will reduce the revenue and principal received by the Trust, however, liquidity remains available through existing structural mechanisms and note principal payments are modest in the next 12 months. Notwithstanding this, Bank of Scotland will continue to monitor the Trust.
