The obligation under the U.S. Credit Risk Retention Rules to maintain a seller's interest at least equal to 5 per cent of the aggregate outstanding balance of the notes of all series is different from the requirement to maintain a Minimum Transferor Interest, and each is calculated differently.

Charge Offs	Charge offs represent defaulted receivables which have been written off in the period, having been moved from collections to recoveries.
