In May 2024, **3,818** of our customers in your constituency held basic bank accounts to help them access financial services. **3,615** of our customers were receiving Universal Credit – an increase of **26.9%** since May 2023.

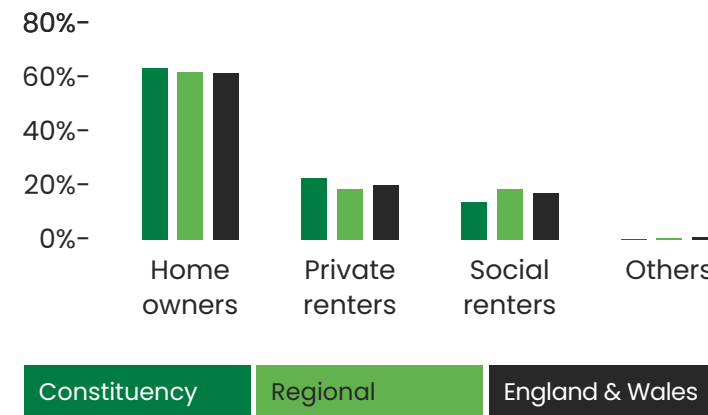

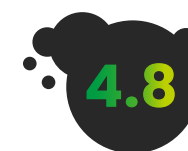
