In May 2024, **2,180** of our customers in your constituency held basic bank accounts to help them access financial services. **875** of our customers were receiving Universal Credit – an increase of **23.4%** since May 2023.

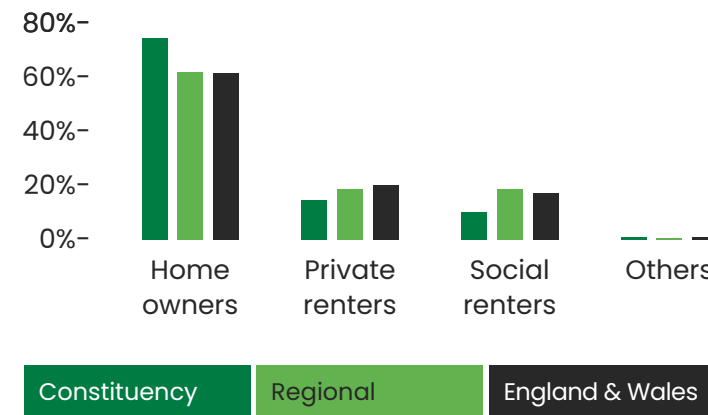
