

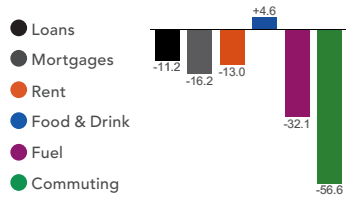
# WIRRAL SOUTH THE NORTH

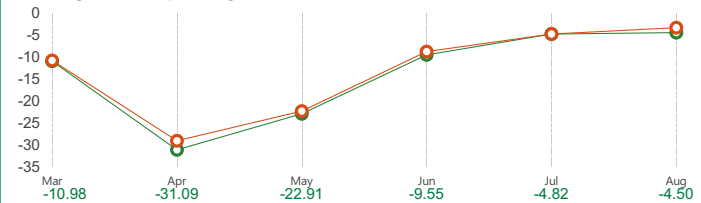


Here's how the spending habits of Lloyds Banking Group's 23,900 personal banking customers in Wirral South have changed over the course of the coronavirus crisis:

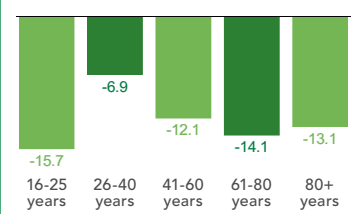
% change in total spending by category since March

Over the course of the pandemic your constituents' average earnings (calculated from payments made into their personal banking account) were:

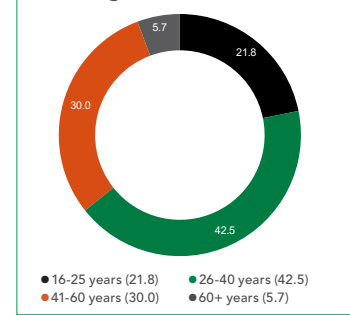

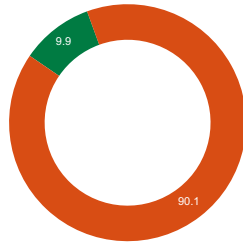

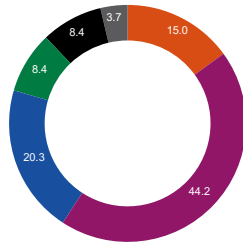
