In May 2024, **5,996** of our customers in your constituency held basic bank accounts to help them access financial services. **4,278** of our customers were receiving Universal Credit – an increase of **22.5%** since May 2023.

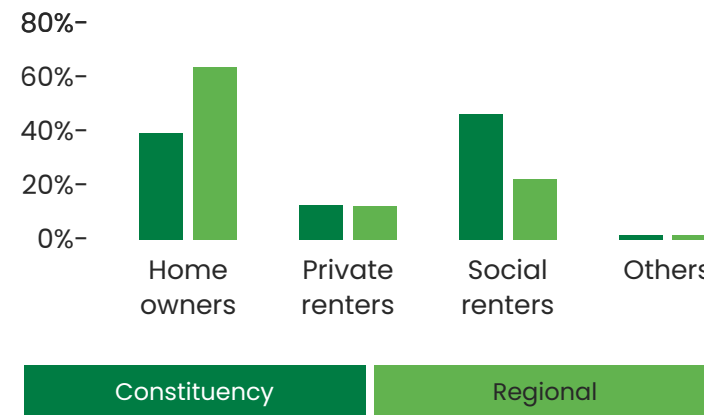
