

GLASGOW SOUTH SCOTLAND

As the country's largest bank we have a responsibility to help Britain recover from the social and economic effects of the pandemic. We want to work with others to help our customers, colleagues and communities in their recovery by focusing on the areas where we can make the most difference. Our scale means we have a relationship with three out of four households in your constituency, and plenty of data to help you better understand your constituents. To support your work we've pulled together some key facts about your constituency, alongside some information on how we have been helping people and businesses in Glasgow South recover from the impact of coronavirus.



Using data modelled from the spending behaviour of Lloyds Banking Group's 34,580 personal banking customers in your constituency, here's how their spending habits changed between March and August 2021 and the same period in 2020, and how they compare to other parliamentary constituencies in the UK:

Mean total spending per person per month was **£1,863** (UK Average: £1,929)
This ranks 365th out of all parliamentary constituencies, a 21.7% change compared to the same period in 2020

We've collaborated with the Sustainability Research Institute at the University of Leeds to calculate the average carbon emissions generated by the spending of Lloyds Banking Group customers. In 2020 our customers in your constituency generated 8.35 tonnes of carbon each – 14.5% less than in 2019. That's the equivalent of powering 2.3 homes for a year

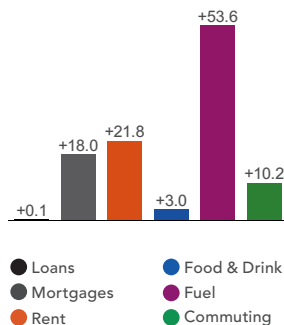

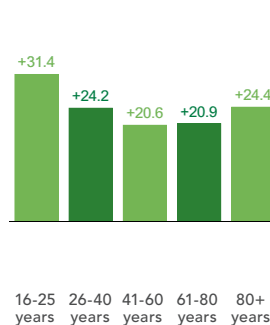

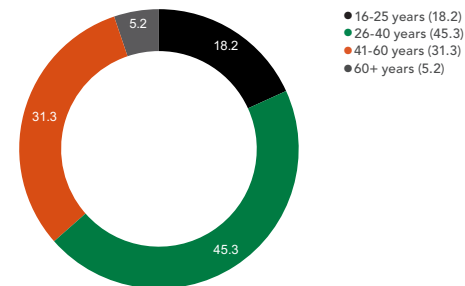
