In May 2024, **5,448** of our customers in your constituency held basic bank accounts to help them access financial services. **3,004** of our customers were receiving Universal Credit – an increase of **11.7%** since May 2023.

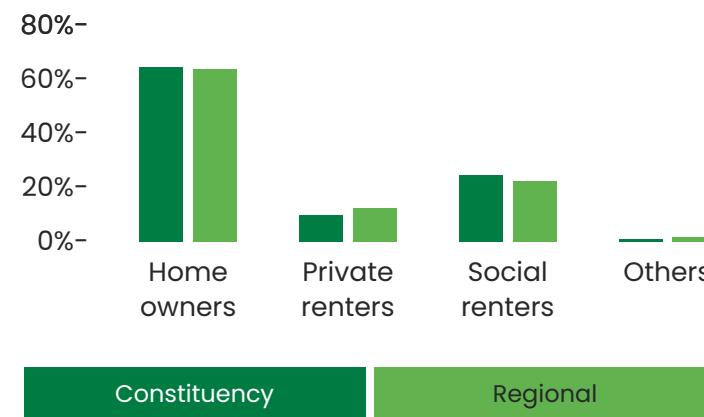
