-  received **£1,706** into their account each month, an increase of **5.3%** on the previous year
-  had a balance of **£3,461** in their bank account, a decrease of **11.5%** on the previous year
-  had a balance of **£8,836** in their savings account, an increase of **5.9%** on the previous year

In May 2024, **2,773** of our customers in your constituency held basic bank accounts to help them access financial services. **2,031** of our customers were receiving Universal Credit – an increase of **15.3%** since May 2023.


