



# RICHMOND (YORKS) YORKSHIRE AND THE HUMBER

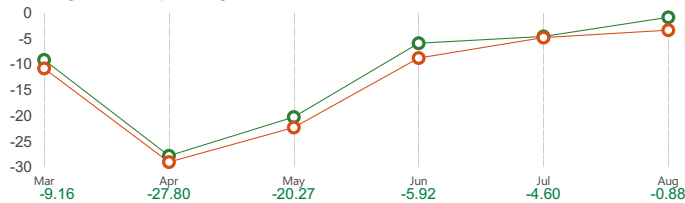

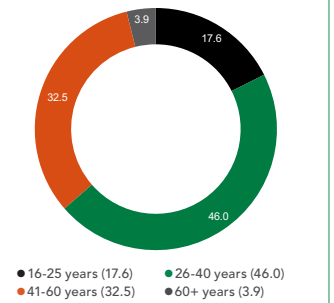

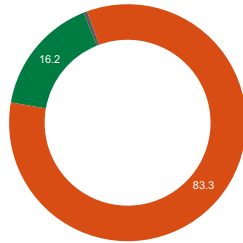

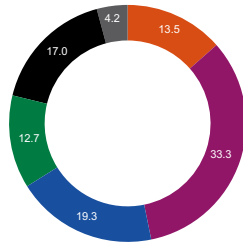
