



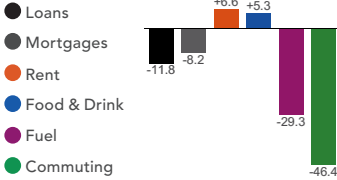

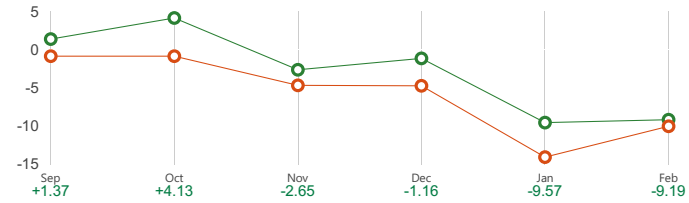

Here's how the spending habits of Lloyds Banking Group's 40,128 personal banking customers in Scunthorpe have changed over the course of the coronavirus crisis:

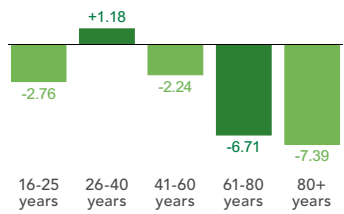
% change in total spending by category since March 2020

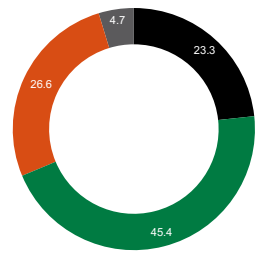
