In May 2024, **2,262** of our customers in your constituency held basic bank accounts to help them access financial services. **992** of our customers were receiving Universal Credit - an increase of **16.8%** since May 2023.

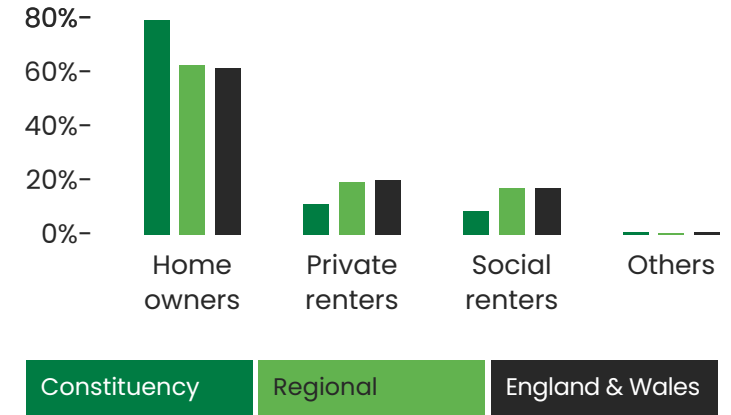
