This Supplement (the “**Supplement**”) to the prospectuses, each dated 17 April 2018 and listed in the Schedule hereto, each of which, as supplemented by the supplementary prospectuses dated 26 April 2018 and 1 August 2018, comprises a base prospectus (the “**Prospectuses**”, and each a “**Prospectus**”) for the purposes of Article 5.4 of Directive 2003/71/EC, constitutes a supplementary prospectus for the purposes of Section 87G of the Financial Services and Markets Act 2000 (the “**FSMA**”) and is prepared in connection with the Programmes (as defined herein) established by Lloyds Bank plc (the “**Bank**”).

This Supplement is supplemental to, and should be read in conjunction with, the Prospectuses and the documents incorporated by reference therein. Capitalised terms used in this Supplement but not defined herein shall have the meanings ascribed to them in the Prospectuses.

The Bank accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Bank (having taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

**Purpose of this Supplement**

The purpose of this Supplement is to incorporate by reference into each of the Prospectuses:

- (a) the Q3 2018 Interim Management Statement (as defined in this Supplement), which was published via the RNS on 25 October 2018;
- (b) the September Board Changes Announcement, which was published via the RNS on 3 September 2018;
- (c) the Strategic Partnership Announcement, which was published via the RNS on 23 October 2018; and
- (d) the Retirement of Chief Financial Officer Announcement, which was published via the RNS on 25 October 2018.
